





PANHANDLE COWBOYS INFORMATION

We shoot on the second Sunday of each month. Our next match is December 12, 2010.

Set up time will be between 7:30 am to 8:00am. Match sign-up will be from 8:00am to 8:45am. The mandatory safety briefing will begin at 9:00am. Shooting begins at 9:30am.

The match fee is \$15.00, unless you are one of the morning set-up waddies, in which case your match fee is \$10.00. Please fill in the requested information of the entry form. This information is need for reporting purposes.

At this point, match directing responsibilities have been divided into “Committees” as follows:

Match Director – Cody Breaker

He will perform the administrative duties, such as; consulting with the committee members to ensure all is in readiness for the next match. He will be the main interface with the ERML, generating the match report for, and presenting same to ERML at their monthly meeting.

Match Operation – Mad Dane, Ned Whiskey and Alabama Shootist

They have been nicknamed the “Tricky Triumvirate” by someone with a sense of humor? They will be responsible for stage writing, selection of targets and props for each stage and, ramrod the waddies for match set-up and take-down. They will, also, handle pre-match announcements and the safety briefing.

Trophy Wrangler – Grundy

Grundy will ensure trophies are available for each match by purchasing the necessary trophies/plaques as needed, and coordinating with the Match Director and Panhandle Cowboys Treasurer for the funding.

Match Scoring – High Card

High Card will continue to do as he has been doing. Basically, he will input match scores into the onsite laptop during the lunch break, and after the match to determine match and category winners, clean sweep winners, and stage winners. He will, also, publish scores/match results, and the **PANHANDLE COWBOYS GAZETTE** to everyone on the Panhandle Cowboys e-mail list via electronic means.

Editor – Panhandle Cowboys Gazette – Rocky Lane




WHO IS ROCKY LANE?

It has been brought to my attention that most of you have never seen me. I did a little research and discovered, much to my surprise, that, apparently, I have not shot a CAS match anywhere since October 2006. Wow! I had not realized it had been that long. In fact, as near as I can determine, the last two matches I shot were in October 2006. One match was with the Panhandle Cowboys, and the other, the Virginia State Championships in Roanoke, Virginia, where I shot a clean match. So, the following is to introduce myself to those of you who do not know me. (And those who do know me probably do not care anyway.)



The photo at left was taken some time back while timing for Rob N Rustler, whereas, the photo at right is the Republic Pictures version of Rocky Lane. Since my photo was taken, I have added a little weight, but am now losing that weight and a little extra. (I have, also,



become more handsome, and more modest.) In fact, I have ordered a new gun rig from Jim Lockwood, Jr. of Legends in Leather, for a pair of consecutively numbered Cimarron Model P .44-40 sixguns. However, I began CAS shooting in Roanoke, Virginia, in the spring of 1995, and eventually became Match Director for a couple of years before moving back to Pensacola in 1999. (I am a Pensacola native.) I have a bunch of first place plaques from Roanoke, and, I shot monthly matches at two North Carolina CAS clubs, and have a few first place wins from them (very few). One of the clubs was one of the two oldest CAS clubs in the eastern United States. In fact, one of the cowboys had SASS badge number 42.




In 1998 I shot the Appalachian Showdown VII in West Virginia, before the match became the West Virginia State Championships, finishing Fourth in Traditional, and Fifth overall, and won the Long Range Rifle Pistol Caliber side match. This match was presented by the other of the two oldest CAS clubs in the eastern United States. (They could never agree as to which club was the older of the two, only that they were the two oldest clubs in the eastern United States.)

In 1999, I shot The Reckoning in Central Florida finishing Second in Semi-Senior. In 2000, I shot The Reckoning again, finishing Third in Semi-Senior and winning the Long Range Rifle Pistol Caliber side match. At the time, The Reckoning was billed as the Florida State Championships. This was before SASS established their state championships program.

In 1999, 2000, and 2001, I shot three consecutive clean sweeps at Shootout at Mule Camp, the Southeast Regional Championships. Rumor had it that no one had ever shot three consecutive clean sweeps at Mule Camp before then. Do not know for sure, but it was the rumor at the time. In the 1999 match I had a rifle malfunction, and since the rifle was the first firearm of that stage, and I did not get off the first shot of the stage, the time for the stage never started. I finished the match with a borrowed rifle. At Mule Camp in 2002 I shot in the Senior Duelist Category and finished fourth. I had a rifle malfunction in that match too, that cost me seven or eight misses. Never found out what was wrong with that rifle, as it has never missed a beat since. Just bad vibes that day I guess. In 2003 I shot Mule Camp again, and had another clean sweep.



As for as shooting with the Panhandle Cowboys, my first shoot with them was in October or November 1997 when my family and I returned to Pensacola on vacation to visit family. I won that match, and the Prairie Hunt side match. Then, in 1999, my family and I moved back to Pensacola, and, I offered whatever assistance I could to the match director. After Capt Bobbie D became match director, along with writing stages from time to time, I began writing the newsletter in August 2002. I have three or four boxes of trophies from the Panhandle Cowboys for clean sweeps, or first place in whatever category I chose to shoot, or trophies for winning a stage. There are, also, trophies, or plaques, displayed on my fireplace mantel, and, on a bedroom wall and bookcase. Never could beat Navajo Kid or The Yank though.



Why have I not been shooting CAS since October 2006? A couple of reasons, the main one being knee problems, I guess. It got to the point where it would take three to five days after a match for my knees to settle down to the discomfort and pain level I was accustomed to. Now, after about three, or so, years of knee injections, I have reached the point where daily activities are too much for the knees and I have an ap-

pointment with a surgeon to see about knee replacement. After both knees are replaced I should be able to run, jump, and play again.

In case you are wondering, I do a good bit of plinking, a bit of practicing with my CAS guns and do some trap shooting. I, also, take my eighteen (almost nineteen) year old grandson shooting from time to time. Hope to get him involved in CAS shooting next year. Have to wait and see. He does get a special joy in the times he has beaten me at trap. I will learn to concentrate one day. You know, wood to wood, and do not think of anything before calling for the bird. (My last trap shooting on November 7, I shot a twenty-three and a twenty-five, and my brother

shot a twenty-four and a twenty-five. Some people have a knack for shooting; others (like me) have to work at it.)

Well, I guess about two pages of me is more than enough. Luck to you at our December match.
